**1. NRW Road:**

**Rd 144 between Rd16 and 18.5 – 2.5 miles x 9m wide x app. 30” deep. (Frost boils, mud punching through surface of road)**

**-app. 17 locations 449m long x 6m wide x app. 30” deep (Frost boils, mud punching though surface of road)**

**Approx cost : \$117 862.50**

2. Rd 20E between Rd136 and Rd137 – 1300m x 9m wide (Geotextile blanket showing, needs to be covered with min. of 8” of gravel (3,200 Yrds))  
Approx Cost : \$55 520.00
  
3. Rd 3 between Rd129.5 and Rd131 - 137m long x 6m wide x app. 30” deep, 40m long x 6m wide app. 30” deep (Frost boils, mud punching threw surface of road)  
Approx Cost: \$46 462.50 CARRIED
